Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. The Spider[®] V Instagram Video Contest (the "Contest") and these Official Rules are governed, construed and interpreted under the laws of the United States. Valid only to legal United States residents (excluding Puerto Rico, US Virgin Islands and Guam) who are eighteen (18) years of age and older at time of entry. All federal, state, local laws and regulations apply. Void where prohibited, taxed, licensed or restricted by law.

CONTEST PERIOD. This Contest begins on December 1, 2017, and ends on December 31, 2017 ("Contest Period").

CONTEST SPONSOR. This Contest is sponsored and administered by Line 6, Inc., 26580 Agoura Road, Calabasas, California 91302 (the "Sponsor"). Participants agree to be bound by these Official Rules and the final decision of Sponsor.

The Contest is in no way sponsored, endorsed, or administered by, or associated with, Instagram, Inc. ("Instagram").

HOW TO ENTER: Participants must have an Instagram[®] account (participants who do not have an Instagram account may sign up for an account at www.instagram.com). Enter on-line by posting to your Instagram account with the following rules:

1. Use the "Pasadena Rock" drum loop preset as a backing track
2. Record up to 60 seconds of participant playing an original musical creation on any Spider V amplifier
3. Post the video to your Instagram with hashtags: #SpiderGrooveContest and #Line6.

All entries are deemed made by the holder of the Instagram account.

By tagging their Instagram videos with the #SpiderGrooveContest and #Line6 hashtags, participants willfully enter the Contest and represent that they have all necessary rights to grant a license to the Sponsor to publish and re-use their video for any purpose without compensation and that they hereby grant such license together with the right to use their name. Only one (1) entry per person. If multiple entries are received from any person or Instagram account, all subsequent entries will be disqualified.

All entries must be received no later than December 31, 2017.

DRAWING. The winner will be determined by Sponsor's staff from among all eligible entries. The winner will be notified by e-mail or Instagram and need not be present to win.
