

## Helix Native Discount Program Terms and Conditions

Qualified Purchasers can receive Discounts on a Helix Native license when they purchase and register an Eligible Product according to these terms and conditions (the “Terms and Conditions”).

### I. Definitions.

- a. **Qualified Purchasers:** A “Qualified Purchaser” is an *individual* who *purchases* (or has purchased) an **Eligible Product** (as defined below) from an **Authorized Reseller** (as defined below) and *registers* (or has registered) the Eligible Product with Line 6 at [www.line6.com/support/account-services](http://www.line6.com/support/account-services).
- Registration of the Eligible Product is required for a Qualified Purchaser to demonstrate that he or she qualifies for the Discount. Line 6 reserves the right to cancel purchases made by purchasers who do not qualify as Qualified Purchasers.
  - Public entities, government entities, nonprofit organizations, educational institutions, enterprise purchasers and business purchasers do not qualify as Qualified Purchasers.
- b. **Eligible Products:** “Eligible Products” include HX Effects™, HX Stomp™, Helix® Floor, Helix® Rack, Helix® LT, POD Farm® Platinum, and POD Farm Standard only, subject to the following conditions:
- Eligible Products must be purchased as new or as products that are designated by Line 6 as refurbished/“b-stock” products (“Authorized B-Stock”) from an authorized Line 6 reseller (an “Authorized Reseller”).
  - Purchases of Eligible Products from online auctions are not eligible for this Offer.
  - Eligible Products do not include open box items or returns sold “as is” or products that have already been registered with Line 6 by another end-user (except in the case of Authorized B-Stock).
  - Eligible Products must be owned by the Qualified Purchaser for a period of no less than one hundred eighty (180) days in order to qualify for the Discount.
- c. **Discounted Product:** The “Discounted Product” is the Helix® Native audio plug-in.
- d. **Discount:** The “Discount” is the amount by which the price of the Discounted Product will be reduced for the purchase of an Eligible Product by a Qualified Purchaser. The Discount varies based on the Eligible Product purchased by a Qualified Purchaser as set forth in the table below.

- II. Offer:** Qualified Purchasers who purchase (or have purchased) and register (or have registered) an Eligible Product may receive the applicable Discount on the purchase of a Discounted Product. The Discount will be reflected in the final purchase price at the time of purchase of the Discounted Product. The Discount is not a “gift”. This Offer expires when the purchase of the Discounted Product is complete. Limit one (1) Discounted Product per qualifying Eligible Product purchase and registration. A Line 6 Account (see [www.line6.com/support/account-services](http://www.line6.com/support/account-services)) and an internet connection are required to purchase and activate a Discounted Product pursuant to this Offer. Line 6 reserves the right to conduct random audits of all Line 6 Accounts, Eligible Product registrations, and Discounted Product licenses in order to ensure compliance with the Terms and Conditions of this Offer. If Line 6 determines, in its sole discretion, that a purchaser who participated in this Offer was not a Qualified Purchaser, that purchaser shall be solely responsible for paying Line 6 the amount of Discount that the purchaser or for returning the Discounted Product for a refund of the amount originally paid.
- III. Eligible Product Returns, Exchanges, and Third Party Sales:** Returns and exchanges of Eligible Products are subject to the policy of the Authorized Reseller from which the original purchase was made.
- If an Eligible Product is returned to the Authorized Reseller or exchanged for a non-eligible product within one hundred eighty (180) days of the purchase of the Discounted Product,
    - the Discount may be deducted from the amount of the return or exchange, as applicable, and any remaining difference charged to the Qualified Purchaser; or
    - the license for the Discounted Product may be revoked until the Qualified Purchaser complies with all of the Terms and Conditions of this Offer or the Qualified Purchaser pays the full retail price for the Discounted Product.
  - If an Eligible Product is sold by the Qualified Purchaser to a third party within one hundred eighty (180) days from the date of purchase from the Authorized Reseller,
    - the license for the Discounted Product may be revoked until the Qualified Purchaser complies with all of the Terms and Conditions of this Offer or the Qualified Purchaser pays the full retail price for the Discounted Product.
  - If an Eligible Product is exchanged for another Eligible Product where the Discount is less than originally received by the Qualified Purchaser,
    - the difference in the eligible Discount may be charged to the Qualified Purchaser; or
    - the license for the Discount Product may be revoked until the Qualified Purchaser complies with all of the Terms and Conditions of this Offer or the Qualified Purchaser pays the full retail price for the Discounted Product.
- IV. Discounted Product Returns:** The Discounted Product may be returned to the Authorized Reseller or Line 6, as applicable, for a full refund within thirty (30) days of the date of purchase.
- V. Offer Restrictions:** This Offer is limited to Eligible Products in-stock and available only while supplies last. Applicable tax, if any, is the sole responsibility of the Qualified Purchaser. Line 6 does not allow product substitutions, deletions, additions or other modifications to this offer, regardless of information you learn from other sources. Line 6 is not responsible for

misinformation about this Offer that you may have received from other sources. Void where prohibited, taxed, or restricted by law. Line 6 may end this Offer at any time, for any reason. Line 6 is not responsible for any loss, destruction or theft of your Eligible Product or Discount Product. In order to determine that you are a Qualified Purchaser, Line 6 may receive personal information about you from the applicable Authorized Reseller from which you purchased your Eligible Product and/or the Discount Product. Line 6 may use any information provided by you or an Authorized Reseller about you in accordance with its privacy policies posted online at [www.line6.com/privacypolicy](http://www.line6.com/privacypolicy). **Line 6 reserves the right to change without notice the Terms and Conditions of this Offer or to modify or end this Offer at any time without notice.**
